
### Summary


The attendance boundaries for Pope Francis CES and Our Lady of Fatima CES have been identified for review in the Boards Long Term Accommodation Plan. The boundary review process is set to begin, and the Local Boundary Review Committee (consisting of the school Principals, school Superintendents, the local Trustees, Planning staff, Child Care staff, and Student Transportation Services staff) will be hosting a Public Information Session for all stakeholders in the Pope Francis CES and Our Lady of Fatima CES school communities.

The Public Information session will be held on Wednesday, January 31st, 2018 from 7:00 pm – 8:30 pm at Pope Francis Catholic Elementary School.

Accommodation Options will include the redirection of areas located north of Major Mackenzie Drive, currently attending Our Lady of Fatima CES, to Pope Francis CES. Board staff would like to discuss the options proposed, the transition process, and encourages all families in the Pope Francis and Our Lady of Fatima school communities to attend the information session.

The public information session being held is designed to facilitate the exchange of ideas and information regarding the boundary study. The meeting will take the form of a "drop-in" session, with tours of the school available. There will be a number of geographical displays and text boards presenting the relevant background information.
